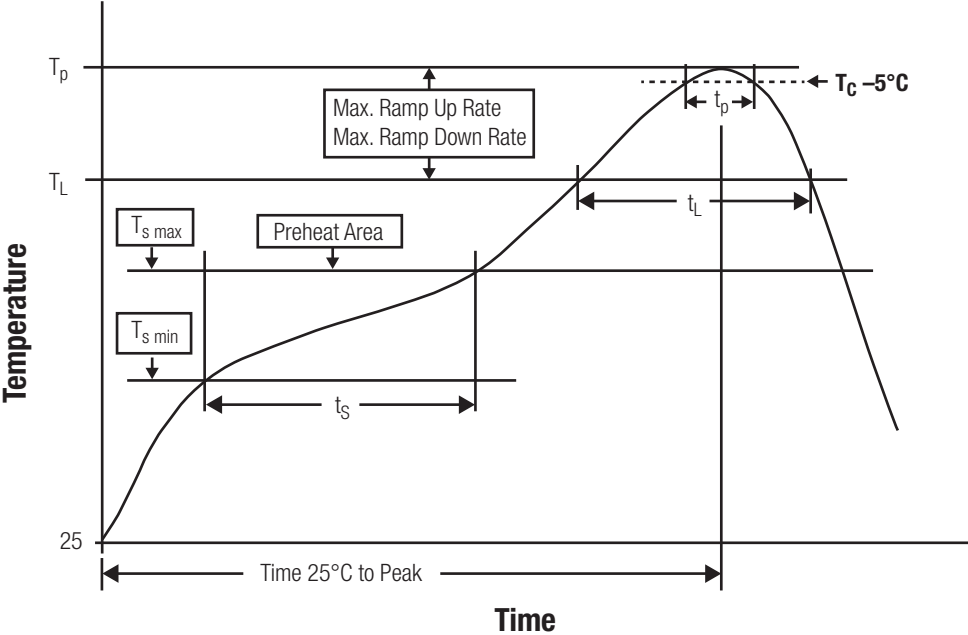

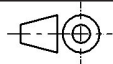
Packaging:

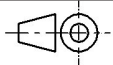
