Backplane Connector Housings(19)

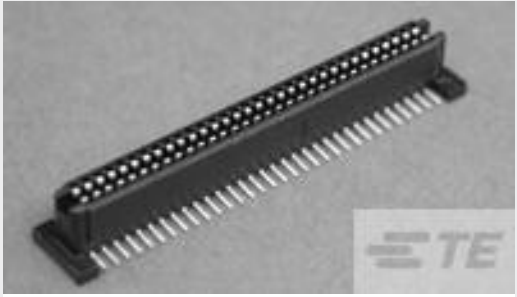


Hard Metric Backplane Connectors(1)

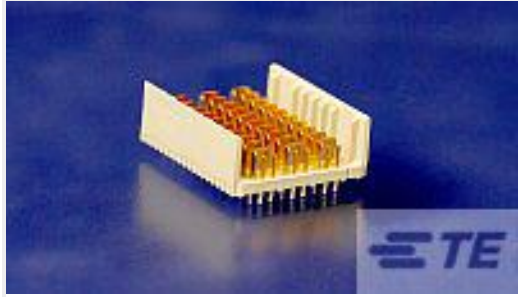
