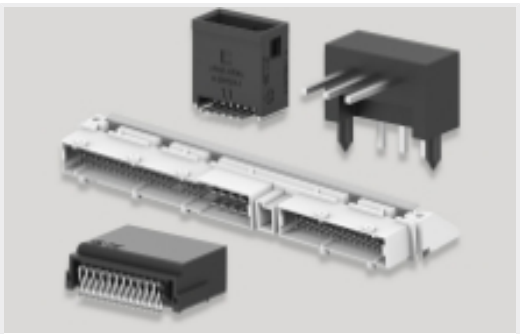

Hard Metric Backplane Connectors(1)

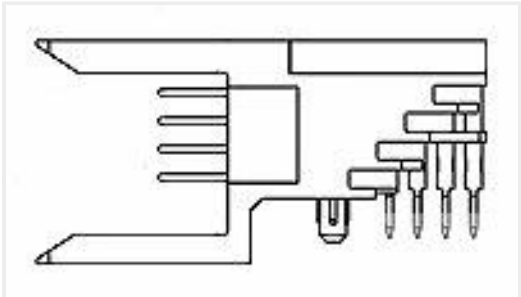

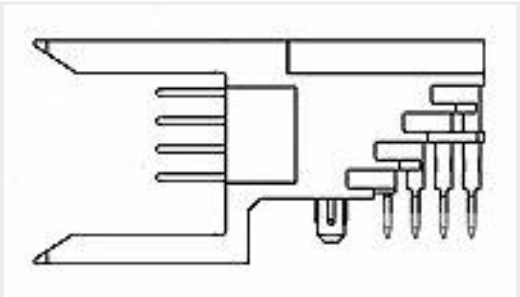
