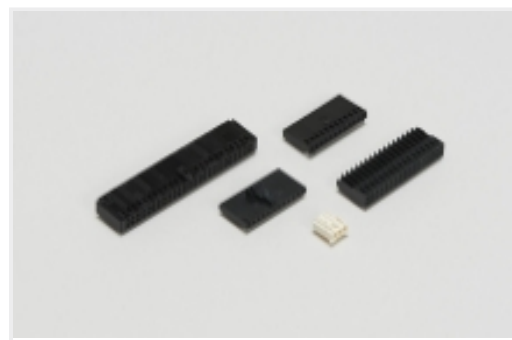




PCB Terminal Blocks(37)
