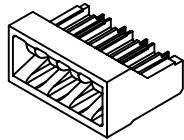


ISOMETRIC VIEW OF TERMINATED PLUG

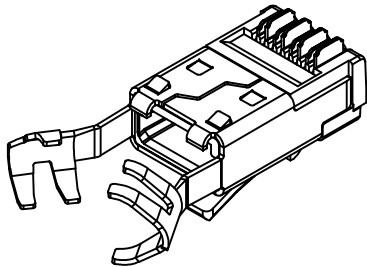
